



## **The Craig School COVID-19 Parent/Guardian & Student Agreement 2020-2021**

**The Craig School** will do its best to:

- Provide an environment which has been risk assessed in response to COVID-19 infection.
- Adhere to the social distancing rules as set out by the local, state, and federal government as much as we reasonably can.
- Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs.
- Contact parents/carers if your child displays symptoms of COVID-19 as this will mean you will all need to self-isolate for at least 14 days or until the test comes back negative (test results must be shared with school).
- Continue our clear and consistent approach to rewards and redirection for children as set out in the Behavior Policy as well as the expectations outlined in this agreement.
- Communicate between home and school through notices, newsletters, text, email and the school website.

As **Parent/Guardian** of a Craig School student I know and understand:

- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 14 days as a family. I will get them tested and I will let the school know as soon as possible via telephone.
- If my child, or another child my child has been exposed to, shows symptoms of COVID-19 at school, I will collect my child from school immediately.
- When dropping my child off and picking them up, I will stay in my car.
- When dropping off and picking up, I will strictly stick to the school timings for my child.
- I will ensure lunch boxes are and water bottles are labelled and disinfected each day before they come to school.
- My child will have their temperature taken on arrival and during the day if they feel, or present, as being unwell.
- I will need to remind my child about social distancing rules but accept they are difficult to follow and that my child may not always do this successfully.
- My child will need to use good hand, nose and mouth hygiene measures.
- I will not be allowed into the school without being granted permission. I will communicate via phone or email to gain permission.
- I will drive through the drop off lane and drop my child off at the door. I will leave immediately through the lane (one-way system). If I need to speak to a member of staff I will do this via email or phone.

- I need to support all staff in their efforts to create a ‘safe as possible’ environment during this crisis.
- I will read all letters/messages/emails that are sent home.
- I need to inform the school immediately of any changes to parent/carer and emergency contact details.
- If my child is deemed unsafe, they will be sent home and cannot return until they can be safe.

As a **student** at The Craig School I will do my best to:

- Adhere to the social distancing rules in class and in the playground areas.
- Tell an adult if I feel unwell.
- Not bring things into school from home that I do not need for school.
- Keep six (6) feet from others.
- Only enter and exit the school building from the designated doors and hallways.
- Follow good hand, nose and mouth hygiene: coughing and sneezing into a tissue.
- Follow good hand hygiene – use soap and water for 20 seconds/hand sanitizer.
- Behave well at all times to maintain the safety of myself and others.
- Follow these expectations and know that if I don’t I will be sent home and will not be able to come back into school until I can be safe.
