## **The Craig School COVID-19 Parent and Student Community Commitment Social Contract 2020-2021**

### **As The Craig School, we commit to:**

- Following guidelines and regulations from the CDC, local health department, the NJ Department of Education, and the NJ Department of Health.
- Continuing to provide an educational environment that is mission-driven and rooted in our core values.

### **As Parent/Guardian of a student at The Craig School I know and understand that:**

- I am expected to screen my child for symptoms daily by asking if they are experiencing: fever, chills, cough, difficulty breathing, myalgia (muscle aches), headache, sore throat, nausea or vomiting, diarrhea, fatigue, congestion, runny nose, or new loss of taste or smell.
- If my child, or anyone in my household, shows symptoms of COVID-19, or has, within the past 14 days, been in close contact with an infected person (within 6 feet of for at least 10 minutes) or has, within the past 14 days, traveled to an area of high community transmission I will not send them to school.
- Cooperate with contact tracing inquiries within 24 hours by, among other things, responding to texts and calls from contact tracers and answering all questions about my child's contacts honestly and completely.
- If my child, or another child, shows symptoms of COVID-19 at school, I will collect my child from school immediately.
- I will notify the LS/MS Nurse or HS Nurse if my child or I test positive for COVID-19 within 24 hours of receiving test results.
- I will not be allowed into the school without being granted permission. I will communicate via phone or email to gain permission to the Director of the LS/MS, Director of HS, Assistant Director of LS/MS, or the Head of School.
- During school drop off and pick up, I will stay in the car at all times and adhere to the school arrival and departure times for my child. If I need to speak to a member of staff I will do this via email or phone.
- My child will have their temperature taken on arrival and during the day if they feel, or present, as being unwell.
- I will need to remind my child about social distancing rules, face cloth coverings, and good hand hygiene.
- I will inform the school immediately of any changes to parent/guardian emergency contact information
- If my child is deemed unsafe, they will be sent home and cannot return until they can be safe.
- I will do my best to support all staff in their efforts to create a 'safe as possible' environment during this crisis.

**As a student at The Craig School, I will do my best to:**

- Adhere to the social distancing rules.
- Tell an adult if I feel unwell.
- Keep six (6) feet from others.

Follow these expectations and know that if I don't I may be sent home and will not be able to come back into school until I can be safe.
